1. EXECUTIVE SUMMARY

1.1 INTRODUCTION

Indira Gandhi College of Arts and Science is a first grade institution of higher education established in the year 2002 at Nellikuzhy, Kothamangalam, and an Educational Hub of Kerala. The College is approved by the Govt. of Kerala and affiliated to Mahatma Gandhi University, Kottayam. It is founded & managed by the Indira Gandhi Memorial Trust. Indira Gandhi college of Arts & Science is one of the first grade colleges in the state offering nine postgraduate and Seventeen undergraduate courses in Science & Mathematics, Commerce & Management and Humanities. Besides, the college offers 55 add on courses in various fields. The college has been offering BSc and MSc courses since its inception in the year 2002. Yet, the College is poised for changes to keep pace with the development in the higher education scenario in the country with additions in its infrastructure and instructional facilities. It is hoped that these changes would help in moulding outstanding young professionals in their chosen fields who would get preference in placements in the limited global job market.

Students from all over Kerala and outside the state seek admission here because of its excellent infrastructure, well experienced faculty, separate hostel facility for ladies and gents, internet connectivity and apt learning environment. Presently more than 1700 students undergo training in all the branches together. Moreover, the Management maintains keen intention to begin more programmes so as to cater to the taste and need of the new generation learners. Indira Gandhi College of Arts and Science has an excellent faculty, well-experienced, committed and devoted in imparting holistic training as to make students industry ready. It has state of the art infrastructure with an area of 8228 sq.m in a sprawling campus of 5 acres with, well-laid campus, class rooms, labs, library, hostels and playgrounds.

The Placement and Training Cell of the group of institutions makes it a point to pool in training resources as to improve the students 'employability. Soft Skill and Technical Training is spread through the academic year utilizing even vacations. Students are given ample opportunities for hands own experience through arranged internship. They have been given exposure to the relevant field through bridge courses. Around 50 reputed companies regularly visit our campus. The placement team keeps scanning industries for possible openings.

- Since the region is largely underdeveloped and marginalized, majority of students are academically, financially, and emotionally not up to the usual standard of performance at the entry level.
- Lack of financial support and aid from Government and UGC.
- Comparatively higher rate of faculty turnover.
- Shortage of funds for infrastructural augmentation and modernization.
- No research departments.
- Low demand for MSc. Mathematics, MSc. Physics and MSc Computer Science.
- SC/ST grant and scholarships / free ships from Govt. and other agencies are not available to students.
- Admitted under Management Quota in self-financed colleges. It makes studies in self-financed colleges
- Unaffordable to tribal students.
- Limited industry-institute linkages.
- Lack of academic flexibility and limited role in redesigning curriculum.
- Discontinuance of studies due to financial and social hindrances is not uncommon among students.
- College has no academic autonomy.
- Majority of the teachers does not have doctoral degrees and research experience.
- All classrooms are not made smart.
- Lack of an indoor stadium.

1.3 CRITERIA WISE SUMMARY

Curricular Aspects

Based on the regulations of the University, our college has successfully moulded its own mechanism for the strict and effective implementation and delivery of the curriculum. During the assessment period, the college introduced 25 programmes considering the pulse of the college; our management is very active in establishing innovative programmes and providing well-furnished platform which leads the students to effective learning.

The students at UG level are prompted to choose an open course as well as elective courses in all programmes. Along with this in order to promote their responsibilities towards environment, UG students have to undergo a compulsory course in Environment and Human Rights. The IQAC monitors the curriculum planning infrastructure of the college through a well- documented procedure which involves strategic planning based on University academic calendar and departmental academic plan based on University syllabus college The hand book and departmental advisory committee, regulate the course work of a programme using a course file, outcome assessment sheet, result analysis and A Virtual Learning platform. Periodic student feedback is collected and used to bring about modifications to the process. To enrich the professional skills of students, the college offers seven value added courses. The college strives to promote gender sensitivity, and social responsibility among the students. To ensure the fruitful functioning of IQAC, we have organized a feedback committee which collects and discusses the curriculum feedback taken from the stakeholders. Then this collective opinion on the curriculum is communicated to the University through the teachers of the college who are members in the Board of Studies of the University.

Teaching-learning and Evaluation

IGCAS strictly adheres to the admission guidelines set by the regulatory body. Students are admitted through both Government and Management quotas. At the beginning of the academic year, an induction program is conducted to introduce students to the institution, faculty, and curriculum details. This program familiarizes students with college and university rules and guidelines, and covers various activities and programs essential for a successful start.

At IGCAS, students are encouraged to achieve their goals by participating in extracurricular activities. Training programs are designed to enhance their knowledge and skill sets. Special classes are provided for slow learners to help improve their academic performance. In addition to traditional lecture sessions, our faculty members experiment with innovative teaching methods. To engage students actively in the learning process, IGCAS employs various methodologies, including problem-solving techniques, experiential learning, and participatory learning.

ICT tools, such as computers, LCD projectors, NPTEL videos, and Google Forms, are utilized to enhance the teaching-learning process. Regular activities include guest lectures, field visits, participation in workshops, symposiums, and more. Students are encouraged to participate in a variety of extracurricular and co-curricular activities. A well-established mentorship program supports students' professional interests and provides counseling when needed. IGCAS also creates an academic calendar that includes the dates of exams, internal assessments, important events, and breaks to help plan the sequence of events for better results.

Research, Innovations and Extension

IGCAS promotes research, innovation, and extension activities among its students and faculty members. The institution encourages faculty to pursue PhD programs, focus on research and development in their respective fields, publish research articles, apply for funded projects, and register patents. Many faculty members at IGCAS hold doctorates, and the institution's R&D Cell actively promotes research activities. The institution offers research grants to provide financial assistance, supporting faculty in their scholarly pursuits. Numerous faculty members have published research papers, patents, and textbooks.

IGCAS has established active MOUs with various organizations to support student projects, internships, and employability. Industrial visits are organized to provide students with practical knowledge and insight into job requirements and preparedness.

The institution has hosted several conferences, national seminars, webinars, expert lectures, and workshops in innovation, research, and entrepreneurship. The Entrepreneurship Cell conducts seminars, workshops, training programs, and interactive sessions with entrepreneurs. Students are encouraged to undertake projects under faculty supervision.

IGCAS offers state-of-the-art facilities for research and projects through various research laboratories established over the past five years. The college's NSS unit conducts various extension and outreach activities, including blood donation camps, tree plantation programs, visits to old age homes, Swachh Bharat campaigns, awareness rallies, and cleaning campaigns.

Infrastructure and Learning Resources

- The college building has been dilated since the inception of the college and is fully fledged with **ICT enabled classrooms, laboratories, seminar halls and open auditorium.**
- The campus is Wi-Fi enabled with CCTV camera installations. To maintain the discipline and decorum of the campus the CCTV surveillance has been guaranteed.
- Two broadband connections with a speed of 500 Mbps (BSNL) and 200 Mbps (Kerala Vision) with multiple service providers are there in the college.
- The campus is becoming more students friendly each year by implementing the facilities like Canteen, Gym, Yoga Center, Water Purifier, central store and Playground. Considering the safety measures the college has installed the fire and safety measures by installing fire extinguishers.
- The campus has a generator, adequate power backup and UPS facilities. The campus is updated with 415 computers, 5 printers, 1 color printer, scanners, LCD Projectors, interactive panels, Photocopy machines and online admission portals.
- Our college has a beautiful landscape, aesthetic architecture, eco-friendly environment, spacious classrooms, and well-equipped laboratories.
- The campus has 3 blocks, a Main block, new block and a library block. There are 5 fully-equipped laboratories for Computer Lab, 1 language lab, 1 Micro Processor lab, Micro Biology lab, Biochemistry lab, zoology lab, Physics Lab, Chemistry Lab, Food Technology lab and Psychology Lab.
- A waiting room and a sick room are provided for women.
- The college has a rain water harvesting unit.
- Our college has well equipped facility to provide first aid and attend to any medical emergencies.

- It also has a well-furnished canteen with large dining space for both vegetarian and non-vegetarian food is also available in the college campus.
- The Cultural Committee engages and nurtures students keeping with the vision and mission of the college to support the holistic development of students' all-round personality development.
- We have both indoor and open auditorium which helps us to conduct many events. The college conducts various events in inside the campus and outside the campus with the support of different clubs for the cultural development of the students.
- Separate rooms for IEDC in the college.
- College Radio nurture the students in musical and cultural activities in the college.

Library as Learning Resource:

The library is automated with the Foresight software.

- The college library is alluringly arranged with maximum fictions, novels, short stories in Malayalam and English, along with multiple reference texts. Students and faculty members can utilize the ample opportunities under the DELNET for all the e-resources.
- The college has a fully automated centralized library with foresight software . The college library has a collection of 10876 books, 6 newspapers, 7 journals, magazines and OPAC are available in library.

Student Support and Progression

To foster consistent advancement in academics, co-curricular, and extracurricular activities, the IGCAS provides an intellectually stimulating environment for students. Students are involved in the decision-making process and are adequately represented on all academic and administrative committees. Over 70% of students benefit from scholarships and freships provided by government and non-government agencies as well as the institution.

Students receive guidance in life skills, competitive examinations, career planning, soft skills training, ICT/computing skills, yoga, physical fitness, and meditation sessions. This support helps them develop life skills, boost confidence, and make informed decisions. Any grievances are addressed by the Grievance Redressal Committee, the Anti-Ragging Committee, and the Internal Compliance Cell. Students can express their complaints about any academic or non-academic issues on campus through online platforms or suggestion/complaint boxes.

The IGCAS has a strong placement record, with an average of 70% of students securing jobs through campus placements. Many students also choose to pursue further education at prestigious institutions both in India and abroad. Numerous clubs and associations facilitate student participation in co-curricular and extracurricular activities. The institution hosts more than 30 competitions, sports, and cultural events annually, encouraging students to participate in university-conducted youth festivals and intercollegiate sports events.

The registered alumni organization actively supports the institution's growth. Alumni contribute significantly to enhancing the teaching-learning process and placement training activities.

Governance, Leadership and Management

Hence the management council has a strategic plan which includes getting NAAC accreditation and Permanent Affiliation for all UG programmes as well obtaining Autonomous in future.

The institute has a well-defined mechanism to monitor effective and efficient utilization of available financial resources for the development of the academic processes and infrastructure development. Internal and External audits are held periodically.

Multidisciplinary/interdisciplinary:</p>	<p>Education with multidisciplinary components is an academic and pedagogical approach aimed at developing students' capacities across intellectual, aesthetic, social, physical, emotional, and moral domains. This is achieved by integrating formal and informal learning opportunities, teaching, research, community engagement, and promoting cross-disciplinary and interdisciplinary perspectives and practices. The NEP 2020 suggests that colleges will gradually phase out the system of "affiliated colleges" over a period of fifteen years, with a target of 2035. This transition will be supported by mentoring from the respective affiliating universities. Our institution is working to implement this approach, taking various steps such as attending seminars and conferences related to NEP 2020, identifying benchmarks from other institutions for multidisciplinary courses, and closely adhering to the norms and regulations of the affiliating university.</p>
<p>2. Academic bank of credits (ABC):</p>	<p>As per the UGC Notification on University Grants Commission Notification (28th July 2021): An "Academic Bank Account" refers to an individual account with the Academic Bank of Credits that a student opens and operates. This account collects and stores all the academic credits earned by the student from various courses. These credits are recognized, maintained, accumulated, transferred, validated, or redeemed for awarding degrees, diplomas, certificates, etc., by an authorized institution. The Academic Bank of Credits will be established similar to the National Academic Depository and will feature a dynamic website with comprehensive details about its operations for all higher education stakeholders. This system is designed to be credit-based, highly flexible, and student-centric. Our institution is in the process of obtaining approval from statutory authorities, including university authorities, to apply for registration with the Academic Bank of Credits. Credits earned by students through online courses from National Schemes like SWAYAM, NPTEL or any specified university will also be eligible for credit transfer and accumulation.</p>

The NEP document highlights India's rich cultural and knowledge heritage, the significance of Indian philosophy in shaping global perspectives, and the importance of the country's multilingual and multicultural background. It underscores the necessity of revitalizing these areas for the betterment of India and the world. This strategy necessitates a paradigm shift from the recent educational system, which has often undervalued traditional Indian knowledge. In alignment with AICTE guidelines and to restore the glory of ancestral values and knowledge, our institution has introduced a mandatory course on the "Indian Constitution and Traditional Knowledge" for all undergraduate students. To complement classroom lectures, students are provided with standard textbooks on the Indian Constitution and the cultural heritage of India. Our Arts Club regularly conducts competitions in Malayalam on contemporary topics such as the environment and energy conservation, as well as on cultural and ethnic values of India. Embracing the spirit of NEP 2020, IGCAS has redesigned its curricula to include the following: Multidisciplinary across all programs Outcome-based education, in place since 2018 Indian Knowledge System, which includes: The inclusion of Indian languages such as Sanskrit, Tamil, and Malayalam Training in Yoga for all students, with a dedicated Yoga Hall named after the Great Indian Saint Swami Vivekananda. Training in employable hard skills and Training in employable soft skills.</p>
<p>5. Focus on Outcome based education (OBE):</p>	<p>Recognizing the importance of accreditation, particularly in relation to the Washington Accord, the college has integrated Outcome-Based Education (OBE) concepts into its curriculum, syllabi, and evaluation methods. OBE has been fully</p>

implemented in all stages of the teaching-learning process across five out of eight undergraduate programs. In line with the graduate attributes, Program Educational Objectives (PEOs), and Program Outcomes (POs) outlined in the NBA documents, markers have been developed and shared with stakeholders. The PEOs have been established considering factors such as preparation, core competence, breadth, professionalism, and lifelong learning. These objectives are aligned with the institution's vision and mission, as well as the vision and mission of individual departments. POs and Program Specific Outcomes (PSOs) have been mapped to the PEOs. Course outcomes have been defined for all courses, and their correlation with various POs has been specified. In the evaluation process, which includes continuous assessment and semester examinations, student performance in each course is linked to the POs and subsequently to the PEOs, with attainment evaluated accordingly. A 360° feedback mechanism is used to continuously monitor and achieve the goals of Outcome-Based Education. Various committees at the college and department levels assess attainment each semester. Documentary evidence is maintained to facilitate peer-level evaluation.

6. Distance education/online education:

There has been a noticeable shift in teaching and learning methods globally, moving from traditional classroom instruction to a blend of classroom and online education. This trend is evident in the growing popularity of online education platforms such as MOOCs. India is also adapting to this new paradigm. We encourage our students and faculty to enroll in and complete examinations through SWAYAM-NPTEL. Under our Curriculum system, we have obtained the necessary approvals to include a Credit Transfer Scheme for our students. Consequently, credits earned from SWAYAM-NPTEL can replace elective courses. The list of such courses is approved by the chairperson before the semester begins to ensure that students register for relevant courses that are not repetitive or duplicative. Online courses have also enabled students to fulfill credit requirements by the 5th semester, allowing them to undertake full-time internships in suitable industries during the 6th semester. This provides students with the dual benefit of acquiring industry-required skills and enhancing

their career opportunities.

Methods Implemented to Foster Transparency in Internal Evaluation

- Effective orientation programs
- Streamlined internal examination calendar
- Transparent rubric communication in assessment steps
- Conducting and assessing various components of internal evaluation
- Robust grievance redressal mechanism
- Seamless access to results via Learning Management System (LMS)
- Engaging parents in student progress

Continuous internal assessment comprises attendance, assignments/seminars, and two internal examinations.

1. Attendance

- Attendance is recorded at the beginning of each class.
- Students can obtain their attendance records from the office or through LMS at any time.
- Students can request duty leave by filling out the application form or using the LMS platform.
- The attendance percentage is published at the end of each semester, and students can apply for condonation if necessary.
- Based on the attendance marked in the LMS, internal marks for attendance are awarded.

1. Assignments/Seminar

- Seminars are optional for UG programs and compulsory for PG programs.
- At least one assignment/seminar is required for each course, and feedback is communicated to the students.

1. Two Internal Examinations

- The internal exam committee prepares the internal exam calendar.
- A week before the exam, students receive notification and timetable of the internal examination via WhatsApp group, notice board, and LMS.
- Aligning and mapping the question paper to Course Outcomes (COs) is done through the use of LMS and Bloom's Taxonomy.
- Submitting the question paper to the Examination Office is done in a timely manner.

- Examinations are conducted in a centralized manner with rigorous and diligent invigilation.
- Answer scripts are evaluated, distributed promptly, and discussions with students are conducted.
- Providing students with the opportunity to review and recheck their internal marks, published in both A Form and B Form.

Methods Implemented to Foster Transparency in External Evaluation

- Share exam fee notification with students and facilitate electronic payment through the college website.
- Distribute exam registration forms by class, verify applications with tutors and the Head of the Department, and enter/verify data in the university portal through the examination wing.
- Share the University exam timetable and exam hall seating arrangements via WhatsApp and notice board with students.
- Share the invigilation duty list with faculty, open the question paper link from the University, and print the question papers at the exam office.
- External valuation of answer scripts is done at University Centralized Valuation Camps.
- The final result of each semester is published by the university.
- Tutors conduct timely result analysis and consolidate the data in a common pool.

Grievance Redressal Mechanism

Exam-related grievances are categorized into three types: Time-related, Conduction of Exam-related, and Evaluation and Assessment-related. To address these, a three-tier grievance redressal mechanism is followed:

- **Level 1: Department Level**
- **Level 2: College Level**
- **Level 3: University Level**

The grievance form is accessible on the Learning Management System (LMP) and the college website and is promptly addressed. Students can submit grievances as letters to the concerned authority or use the online grievance mechanism.

These outcomes usually encompass the knowledge, skills, abilities, and attitudes that students are expected to develop by the end of the program. Achieving these outcomes is essential for maintaining the quality and effectiveness of the program. By implementing regular evaluations and feedback mechanisms, institutions can foster continuous improvement, ensuring that the learning experience adapts to student needs and preferences. This iterative process helps keep courses relevant, engaging, and effective in meeting their objectives.

To assess course outcome attainment, institutions evaluate how well students have met the specific learning objectives of a course. This level of attainment is often expressed as a percentage, derived from students' performance in both internal and external assessments. The average attainment for each course is calculated by averaging the scores achieved by students.

Mapping Course Outcomes (COs) to Programme Outcomes (POs) is a crucial aspect of curriculum development and assessment in educational institutions. This process ensures that the content covered in individual courses aligns with the broader objectives of the entire program. The mapping of COs to POs is carried out through the following steps

Step 1- Link COs to POs: Align the percentage values of outcomes from each set of courses with their corresponding Programme Outcomes (POs).

Step 2- Calculate CO Attainment: Determine the percentage attainment for each group of course outcomes.

Step 3- Allocate COs to POs: Assign the attained course outcomes for each group to their respective Programme Outcomes.

Outcome Attainment Evaluation:

Outcome attainment evaluation employs a two-tiered approach: direct evaluation and indirect evaluation, with respective weightages of 80% and 20%. This method assesses success and identifies areas for improvement, leading to the development of remedial strategies

Direct Attainment:

Direct attainment involves the direct measurement or assessment of specific learning outcomes. In this approach, 80% of the weight is allocated to direct evaluation, which is based on the external and internal marks of each course

Indirect Attainment:

Indirect attainment is assessed through exit surveys administered to students and alumni. The survey format is developed by the Internal Quality Assurance Cell (IQAC).

Evaluation of Course Outcome Attainment:

Assessing course outcome attainment is an ongoing process that informs teaching strategies and improves educational quality. The levels of attainment for Programme Outcomes (POs) are established using the CO mapping matrix. To address any deficiencies, a gap analysis is conducted, which helps in devising corrective measures. This approach ensures that courses achieve their intended goals and equips

students for success in both academic and professional settings.

4.1 Physical Facilities

4.1.1

The Institution has adequate infrastructure and other facilities for,

- teaching – learning, viz., classrooms, laboratories, computing equipment etc
- ICT – enabled facilities such as smart class, LMS etc.

Response:

Indira Gandhi College of Arts and Science is situated on a 5-acre campus in Kothamangalam, offering a well-designed infrastructure that supports a thorough educational experience through its physical facilities, technology, and holistic development programs.

Physical Facilities

The college's infrastructure includes essential amenities such as classrooms, laboratories, and recreational areas. The campus is equipped with Wi-Fi-enabled classrooms and modern technological tools to facilitate effective learning. Each department has access to desktops and high-speed internet. Security is enhanced with CCTV monitoring in classrooms, and water filters and coolers are provided on every floor to ensure safe drinking water. The administrative office, housed in the Main Block, uses Foresight ERP Software for managing admissions, fee payments, and other tasks efficiently. A fleet of seven buses helps transport staff and students from distant locations.

Library and Hostels

The library features a significant collection of 10,869 books, seven journals, and digital resources through DELNET, supporting both academic and personal growth. There are two hostels for boys and girls, with additional residential facilities for teachers. A campus store offers stationery and study materials, and a Prayer Hall provides space for meditation and spiritual activities.

Classrooms and Seminar Halls

The institution includes 48 smart classrooms with ICT facilities to enhance teaching and learning. Two seminar halls, equipped with computers, LCD projectors, and audio systems, are used for various academic and professional events. Additional facilities such as LCD projectors, LED TVs, and video conferencing tools support a range of educational activities.

Laboratories

The college provides specialized laboratories for different disciplines:

- **Computer Labs:** Five labs with 385 computers, including a Language/Communication Lab with 36 computers.
- **Science Labs:** Equipped labs for Physics, Chemistry, and Psychology, as well as specialized labs for Food Technology, Cyber Forensics, Bioscience, Biochemistry, and Zoology.

Computing and Connectivity

The college uses Core i3 processors in its systems and offers free internet access to both staff and students. It benefits from a high-speed 500 Mbps BSNL FTTH broadband connection, 20 controlled Wi-Fi access points, and a 190 KVA generator for a reliable power supply.

Sports and Recreation

The campus includes various sports facilities such as an outdoor ground, a table tennis court, a badminton court, and a gymnasium. At our college, technological advancement seamlessly intertwines with educational excellence, creating

an environment that fosters both learning and innovation. Central to this effort is our state-of-the-art IT infrastructure, designed to support and enhance the academic experience for both students and faculty.

Our campus is well-equipped with a comprehensive array of IT facilities, featuring a total of 415 computers. Of these, 385 are accessible to students across various labs and the library, ensuring that every learner has ample opportunity to engage with digital resources. The 5 computer labs, 1 language lab, and 1 microprocessor lab are the primary spaces where students can access these computers, which are available from 9:30 am to 4:00 pm. These facilities not only support daily coursework but also accommodate add-on and certificate programs, as well as mini and major projects for final-year students.

In addition to individual departmental computers and Wi-Fi connectivity, the campus is outfitted with robust broadband connections: Kerala Vision with a bandwidth of 500 Mbps and BSNL with 200 Mbps. This dual setup ensures smooth and fast internet access across the college, which is crucial for both academic and administrative functions. Our Wi-Fi infrastructure is periodically updated by Kerala Vision Broadband Limited to maintain optimal connectivity, and our campus is supported by a 90 KW generator to mitigate any potential disruptions.

Safety and security are paramount on our campus. With 104 CCTV cameras strategically placed throughout the premises, we ensure the vigilance and personal safety of all students, faculty, and staff. The campus is also equipped with interactive technology to enhance the teaching-learning process. Out of 48 ICT-enabled classrooms, 15 feature interactive panels, while the rest are outfitted with projectors and Wi-Fi/LAN facilities. Additionally, two seminar and conference halls come equipped with smart classroom technologies, further facilitating dynamic and interactive learning experiences.

Our library, a cornerstone of academic support, is automated with Foresight software and houses 21 computers—20 of which are designated for student use. This modern digital library includes an E-Resources Center, which provides access to a vast array of online materials. Alongside traditional resources, the library integrates seamlessly with e-governance systems, enabling efficient management of attendance and progress reports. Quick Heal Antivirus software is installed on all systems to ensure cybersecurity and data protection.

The college's commitment to IT excellence extends to its examination management. The examination control room is equipped with advanced IT facilities to support the smooth conduct of exams. Furthermore, various online platforms like WhatsApp groups and Google Classrooms are employed to enhance communication and the effectiveness of teaching.

Supporting these facilities is a dedicated team of two computer technicians who ensure the maintenance and smooth operation of all IT infrastructure. The use of Embase LMS software, introduced last year, underscores our commitment to leveraging cutting-edge technology to enrich the educational experience.

In sum, our college's IT facilities are not just about technology; they are about creating an integrated and supportive environment that empowers students and faculty to thrive in an increasingly digital world.

Indira Gandhi College of Arts and Science, founded in 2002 in Nellikuzhy, Kothamangalam, is a leading higher education institution in Kerala. Approved by the Government of Kerala and affiliated with Mahatma Gandhi University, Kottayam, the college is run by the Indira Gandhi Memorial Trust.

Funding for the college comes from several sources:

1. **Indira Gandhi Memorial Trust:** Provides financial support and resources.
2. **Student Tuition Fees:** Revenue from student fees used for educational costs.
3. **Alumni Fund:** Contributions from alumni to support college projects and growth.
4. **NSS Fund:** Funding from the National Service Scheme for community service and related activities.

At the start of each financial year, the Principal, Administrative Officer, and Management Representative hold a meeting with department heads, committee members, HR, and the accountant to review and plan the anticipated expenses. The Administrative Office drafts the budget for development, covering infrastructure, furniture, teaching and non-teaching equipment, and technological needs. Student fees are the primary source of financial support for academic expenses, while the Indira Gandhi Memorial Trust funds infrastructure improvements. All financial resources are consolidated into a central fund and allocated efficiently for various projects.

Optimal Utilization of Funds: Each financial year begins with a prepared and verified annual budget to ensure efficient use of resources based on institutional needs. The Administrative Office produces a

detailed income and expenditure statement, reviewed for accuracy and suitability by the Principal and Management. Funds are designated for infrastructure, faculty activities (such as seminars and research), student engagement (including sports and cultural events), and scholarships. Daily transactions are monitored by the college administrative officer and the accounts department to ensure precision and compliance.

Audit: The institution ensures proper accounting and fund utilization through annual financial audits. Both internal and external audits are employed to manage financial resources effectively.

Internal Audit: An internal auditor reviews all college transactions. A team rechecks the use of external resources approved for various departments, conducting detailed financial audits to identify and correct discrepancies. This process is transparent to prevent misunderstandings and adheres to generally accepted auditing standards in India, including:

1. **Compliance Checks:** Verifies adherence to policies, laws, and regulations.
2. **Budget Comparison:** Compares budgeted statements with actual figures.
3. **Asset Safeguarding:** Reviews methods for protecting assets and confirming their existence, such as:
 - Verification of the cash book
 - Examination of the bank passbook
 - Verification of fund allocation and utilization for departments and committees
 - Admission record verification
 - Checking acknowledgment letters for scholarships
4. **Resource Efficiency:** Evaluates the economy and efficiency of resource use, including:
 - Examination of maintenance and miscellaneous expense payments
 - Certification of the audit report
 - Ensuring legal compliance

External Audit: An external audit is conducted annually by a Registered Chartered Accountant appointed by the Trust, following government standards. The Chartered Accountant provides the balance sheet, fixed asset statement, and detailed income and expenditure report. This audit supports the preparation of a systematic budget for the following financial year, ensuring funds are allocated for optimal use and quality enhancement.

The IQAC, in collaboration with the management, inspects and evaluates the performance of non-teaching staff to ensure high-quality work. Green Audits, Energy Audits, and Environmental Audits are conducted annually since the establishment of the IQAC.
