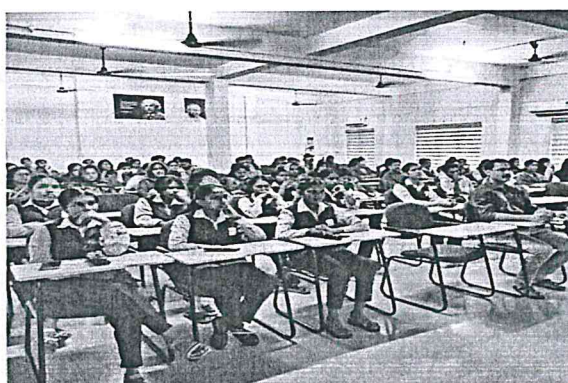

A seminar on "Legal Awareness of Sexual Harassment" was organized by the ICC in association with IQAC to enhance students' understanding of legal protections, rights, and preventive measures related to sexual harassment. The session was conducted on August 7th at Seminar Hall and was attended by students and faculty members. The resource person for the seminar was Adv. Shiga N. P, Central Government Standing Counsel for the Lakshadweep Administration. With her extensive legal experience, she provided insightful explanations on the Sexual Harassment of Women at Workplace (Prevention, Prohibition and Redressal) Act, 2013 (PoSH Act), legal definitions, complaint mechanisms, and the role of Internal Committees.

Adv. Shiga N. P highlighted the importance of creating safe environments, recognising unacceptable behaviours, and promoting gender sensitivity. She also discussed real-case scenarios, rights of victims, responsibilities of institutions, and the legal consequences of harassment. An interactive Q&A session allowed students to clarify doubts regarding legal procedures and reporting mechanisms.
