

### **RE-DVV CLARIFICATION**

#### **6.3.2. PERCENTAGE OF TEACHERS PROVIDED WITH FINANCIAL SUPPORT TO ATTEND CONFERENCES/WORKSHOPS AND TOWARDS MEMBERSHIP FEE OF PROFESSIONAL BODIES DURING THE LAST FIVE YEARS**

##### **Metric Description:**

Percentage of teachers provided with financial support to attend conferences/workshops and towards membership fees of professional bodies during the last five years.

##### **Issue:**

The assigned score for this metric is 0. However, based on the evidence submitted, the expected response is **70.61%**, with an expected score of **4**.

##### **Submitted Evidence:**

1. Financial record details of funds allocated for teachers' participation in conferences/workshops.
2. Copies of Request letters, Vouchers and Certificates of teachers attended with financial support.
3. List of teachers who attended conferences/workshops.
4. Budget allocations for seminars, conferences and workshops.

##### **Request:**

We respectfully request NAAC to re-evaluate this metric based on the thorough documentation provided. Over the last five years **70.61%** of our teachers received financial support to attend conferences/workshops.
